2) CANCELLATION SCHEDULE: Any cancellations or requests for changes of this contract must be made in writing to SPIE, subject to the following fees:

- On or before 27 March 2025 Eligible for full refund less a \$500 administrative fee.
- Between 28 March–27 May 2025 25% of payment forfeited; excess of 25% paid will be refunded in full.
- After 27 May 2025 No refund.
